INTERIM REPORT TO THE STOCKHOLDERS

The Group's 2025 performance reflects the full-year inclusion of Caribbean Producers (Jamaica) Limited (CPJ) and Stansfeld Scott Barbados Limited (SSBL). In comparison, the results for 2024 included SSBL from March and CPJ from July.

Second Quarter Performance (April - June 2025)

For the three months ended June 30, 2025, the Group recorded revenue of US\$150.0 million, representing a 49.6% increase (US\$49.7 million) over the same period in 2024.

- Gross profit rose to US\$42.4 million, up from US\$26.7 million in 2024 a 58.8% increase.
- Operating profit reached US\$8.5 million, a 39.3% rise versus the prior year.
- Despite increased finance costs, profit before tax improved by US\$1.2 million, closing the quarter at US\$5.0 million.

Year-to-Date Performance (January - June 2025)

For the six-month period ending June 30, 2025, the Group reported:

- Revenue of US\$300.6 million, an increase of US\$107.7 million (55.8%) over the same period in 2024.
- Gross profit of US\$84.2 million, up 61.6% from US\$52.1 million.
- Profit before tax totaled US\$10.6 million, compared to US\$8.6 million in the prior year.

The integration of CPJ and SSBL has progressed smoothly, with minimal staff turnover and no disruption to key partnerships. In fact, the expanded ASBH footprint has unlocked new business opportunities, serving as a significant contributor to the Group's strong topline growth. The focus remains on unlocking synergies, scaling operations efficiently, and building internal capacity across the organization.

Operational Updates

CPJ currently has two major capital projects underway:

- Enterprise Resource Planning (ERP) System Implementation While the rollout has presented typical transitional challenges, the system is now in its stabilization phase and is expected to be fully operational by the end of August 2025.
- Upgrade of the Meat and Seafood Processing Facility The upgrade is over 60% complete and is already delivering benefits including higher output, reduced waste, and an improved customer experience. Full completion is expected by December 2025.

Dividend Declaration

The Board of Directors approved an ordinary dividend of US\$0.00195 per share, which was paid to shareholders on July 31, 2025 — in line with the dividend declared in June 2024.

Basis of preparation

Certain accounting entries that are made at the year-end are estimated in these interim unaudited consolidated financial statements. The accounting policies applicable to these interim unaudited consolidated financial statements are consistent with those used in the audited consolidated financial statements for the year ended 31 December 2024.

Acquisition of interests in subsidiaries

During the period the Group acquired 100% of the share capital of H. Jason Jones & Co. Limited ("HJJ"), a company incorporated and domiciled in Barbados, through its subsidiary, Retail Acquisition Company Limited ("RACL"). HJJ is a distributor and retailer operating primarily in the food service industry in Barbados.
